We tried and failed with the Annual Dinner again this year for whatever reason we were unable to attract sufficient interest. From talking with other organisations, we appear to be not alone with this and again it is maybe a way that younger members could come up with suggestions that would attract a cross section of ages.

On a brighter note, we tried a BBQ at Durham Rugby Club and this was well received, next year we hope to add some form of entertainment and music. Thanks to Vincent Dave and Neil for organising this.

Due to the closure of the Town Hall for refurbishment works we had the Martinmas Guild Day on the 3rd February 2025 in the County Hall, strange not to be in the Town Hall with photos on the steps.

Due to the works in the Town Hall, we cancelled the Apprentice awards as we did not feel it was right to have this in any other surroundings than the Town Hall, we are underway with the awards for 2026 (Thanks Neil Graham) and notice for this will be on our new Web Site.

The May Day Guild Day 14th April 2025 was held at The Story, Mount Oswald and due to a problem we had with the catering at County Hall in February, we had with the coffee a slice of Victoria Sponge cake that was very nice (Thank you Rob) If you have never been to The Story it is well worth a visit for a look around and a coffee. This was Mayor Liz Brown's final Guild Day. Vincent Syson, Warden for the Butchers gave an excellent talk and demonstration of the Northumbrian Pipes.

Lamas Guild Day on 4th August saw us back in the Guild Hall. It was good to be back home. At this meeting I had to report that the Charitable Trust had made a decision to shut down after 10 years of good work. I feel I should point out at this stage that the Charitable Trust was a standalone company and the decision to close was made without any consultation with the Freeman. This was the first Guild

Day for the new Mayor Mr Gary Hutchinson, I had been invited to Gary's Mayor making Ceremony on the 11th June and what a privilege to witness this.

Martinmas Guild Day was held on the 3rd November 2025 in the Guild Hall, and we saw for the first time the replacement Charters on the wall, the enhanced colours, I believe, make them look better than the originals. The originals are being kept in The Story in a conditioned environment for safe keeping. Rob King gave us an excellent presentation on the works that had been carried out in the Town Hall and I believe we all came away with a lot of additional knowledge. Rob also reminded us of the Town Hall tours and I suggest all interested to learn a bit more about our Town Hall should take these up.

Geoff Kitson, our official Photographer, has decided to resign from the position and I would like to thank Geoff for all of his work over the years. We have been looking for someone to help with the media work and can confirm that Daryl Metcalf has volunteered to take up the role of Media Officer.

We have now completed the remaining Guild booklets for the Masons and Cordwainers Guilds thanks to Deputy Warden Alan Richardson. Alan has spent a lot of time doing research and formatting the booklets and I would like to thank Alan.

Most of our booklets and publicity leaflets need to be updated and brought into line with recent operational changes of the Durham City Freemen, the first being the Brief History of Durham City Freemen, Alan has again put his head above the parapet and is working on this, thanks Alan.

As one door closes with the Charitable Trust another opens. The Wardens and Deputies are working on a new model to continue with community giving albeit at a reduced level of funding that we can afford for now and controlled totally by the Wardens and Deputies. This will be covered on a later newsletter and on the website.

By now we should have our new Web Site up and running in its new format, I hope it is easier to navigate and it should have a better look on the mobile phones, thanks John Paul Proud for all your work on this.

# Secretary's Report



## Numbers of Freemen

At the time of writing the total number of Freemen stands at 278. Over the year four new Freemen were sworn in, with a further three who have been deferred to a later date to suit the applicants. We are a global community and have Freemen in Australia, Quatar, Spain and Canada.

Out of the total we have 120 (43%) living within the district and 157 are living out of the district. A total of 73 female (26%) and 205 men (74%).



## Membership Criteria

### Guild Servitude, Durham Servitude and Hereditary Freedom.

#### Admission by Application

Applicants should contact the Membership Secretary in the first instance.

Any man or woman who has attained the age of 18 years and has any of the qualifications set out below is eligible for consideration for admission to the Freemen of the City of Durham. The qualifications for eligibility for Freedom of the City of Durham are:

#### 1. Guild Servitude

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen with an employer who is a Freeman of the City of Durham.

#### 2. Durham Servitude

Completed service in an apprenticeship of at least three years duration in a recognised trade, or equivalent trained employment status deemed satisfactory to the Wardens of the Durham City Freemen, in one or more trades within the Durham City boundary.

#### 3. Hereditary Freedom

He or she is the son or daughter of a Freeman of the City of Durham.

#### 4. Customary Freedom Admission by Invitation Only

This entry process is at the discretion of the Wardens, if the invitee is accepted this obviates the need for the first two calls as the Wardens represent their members. Men and women who are currently serving as a Trustee of the Freemen cannot be considered under this item.

Men and women who have attained the age of 18 years who are not otherwise qualified in accordance with 1.2.3. above, may be admitted as Freemen in accordance with ancient local custom or practice subject to the approval of the Wardens.

All claims to Freedom of the City should be supported by sufficient documentary evidence of entitlement to be submitted for consideration by the Wardens of the Guilds meeting collectively. Following due consideration, the decision of the Wardens in respect of any claim to Freedom of the City shall be final.

Honorary Freedom, a civic honour conferred by the former Durham City Council or by Durham County Council linked with the Chartered Trustees, is distinct and separate from the Freedom granted through the eligibility outlined above and the approval of the Wardens.

The rights, duties and powers of the Durham City Freemen shall continue in accordance with the provisions of the Durham City Council Act 1985 and associated customary practice.

**Customary Freedom category invitees are admitted via one call on a Guild Day.**

## Chair of Trustees Report



It's been another fantastic year for Durham City Freeman. It has been really heartening to hear about the hard work of the Wardens and their deputies encouraging new Freemen to join and following the journeys of our apprentices.

We spent most of the last year holding our regular meetings at exile at the Story at Mount Oswald, just outside Durham because the Guildhall in the Market Place was undergoing crucial renovations. We were very grateful that they were able to host us. It was a joy to finally be able to return late in 2025 to the Guildhall when it reopened.

Over the last year while the Guildhall was being renovated, we took the opportunity to have preservation work carried out on our precious Charters so that they will be preserved for future generations to enjoy. We also had a professional review of our heritage silver carried out so that we could ensure it was appropriately insured.

It has been a very positive year for our finances also. We took the decision over a year ago that we needed to bolster our financial resources to ensure that we would be able to rely on our investments to provide an income stream to fund the activities of the guilds if our other income streams reduced or fell away.

High inflation in recent years had meant that the real terms value of our investment assets had started to erode. The trustees were keen to ensure that future generations of freeman would enjoy at least as much income in real terms when adjusted for inflation as the current generation. With this in mind, we switched the way we were investing our funds to a focus on capital growth for the longer term rather than short term revenue. Investment reports from our fund managers, Brewin Dolphin, show that this strategy is working well and we are starting to make up lost ground.

This change in strategy to building back up our investments has meant that there has been a short term reduction in the level of our charitable donations. During the year we were informed by the trustees of the Charitable Trust that they had decided to wind up the trust. A wide range of local good causes received support, including apprentices.

We are all grateful for the impact of the Charitable Trust over the years, and for the hard work of its trustees. Going forward the wardens and deputies of Durham City Freeman have expressed a desire to continue charitable giving, albeit on a more modest scale. This will be undertaken by donations directly from Durham City Freeman to local charities rather than via a separate charitable vehicle.

## Treasurers Report



During 2025 we saw an increase in our investment return, this shows that our strategy to make up for lost capital value is progressing as we hoped.

Our spending has been rationalised by the wardens and a good tight control of our spending. During the year we spent money on looking after our precious heritage assets, such as the charters and a valuation/inspection of our silver.

We will continue to build our investments so that we remain a sustainable organisation for future generations.

## Apprentice Awards



Throughout their history, Durham City Freemen have maintained strong connections with apprentices and the companies operating within the city. For many years, both the Wardens and the Freemen have sought to recognise and celebrate the excellence, achievements, and skills of local apprentices. In 2021, a small group of Freemen began exploring ways to establish an apprentice awards celebration to showcase the accomplishments of apprentices working, training, or living in Durham.

Thanks to the efforts of this group, along with the Wardens and Deputies, the first apprentice awards ceremony took place at the Town Hall on 27 March 2023, where thirteen apprentices were honoured with a prestigious engraved glass trophy, a signed certificate, and a £50 Amazon voucher, each presented by the Lord Lieutenant on behalf of the Freemen.

Following the 2024 awards, which saw nine winners selected from twenty-five nominations submitted by local businesses, New College Durham, Durham University, and Durham Cathedral, the Freemen were informed by the County Council that the Town Hall would be closed for extensive renovations, affecting plans for the 2025 apprentice awards. After careful consideration and discussion with the Wardens and Deputies, it was agreed that relocating the awards to an alternative venue would compromise the event's prestige and significance. Consequently, the decision was made to postpone the awards for a year, using this time to reflect on ways to expand and further enhance the programme for 2026.

Looking ahead, the Apprentice Awards celebration is hopeful of attracting an increased number of nominations from both the business and training sectors. There is also an ambition to introduce a new category recognising companies and organisations that have made outstanding contributions to supporting apprentices across the greater Durham City area.

The Freemen's hope is to continue building on the foundations of the awards, to consult with partners, review feedback from previous events, and explore new opportunities for collaboration and outreach. By embracing change and seeking input from apprentices, businesses, and educational institutions alike, the Freemen aim to ensure that future awards are even more inclusive and impactful.

Moving forward, it is hoped that the Freemen can refine the nomination and selection processes, broaden the range of recognised trades, and further celebrate the remarkable achievements of apprentices and the organisations supporting them, strengthening the legacy and relevance of the awards for years to come.

## Charitable Trust and the Future

It is with regret that we have to announce that at a recent extraordinary meeting of the Durham City Freemen Charitable Trust, the following resolution was agreed unanimously by the Trustees to close the Charitable Trust.

### Resolution

Due to the mounting difficulties of retaining sustainability and maintaining the ethos of the Charitable Trust, it is proposed that the Durham City Freemen Charitable Trust be dissolved and that the assets of the Charity be distributed in accordance with clause 20 of the Declaration of Trust dated the 23rd of January 2015, made by Roger Charles Norris, Stewart Atkin, Alan Ribchester and John Heslop and that the Charity Commission for England and Wales be notified in accordance with the said Declaration of Trust.

Dated 22nd July 2025

The remaining funds held by the Charitable Trust have now been distributed.

However, the Wardens have agreed to continue the role of the community giving albeit in a different format and with a reduced financial contribution. Durham City Freemen have a long history of supporting worthy causes and charities within the locality and want to continue this into the future.

Garry Dunnill Chair of the Wardens said “detailed plans have yet to be finalised, but it is hoped that the new project would be up and running from the start of April 2026.”

### Engagement with the Community:


The Freemen can play an active role in the community, contributing to local events, initiatives, and charities. This not only makes them more relevant but also allows them to give back to the community.
